

# **History of NCSU HUB efforts**

NC State University first made its commitment to HUB utilization in July 1999. With the support of **Charles Leffler**, then Associate Vice Chancellor for Facilities, my work plan for the fiscal year 1999-2000 committed us to "increase Historically Underutilized Businesses in informal construction projects" - the first written commitment to what has turned into an exciting and beneficial set of actions for NC State. Since projects less than \$100,000 (what was then an "Informal" project) were the only projects we did not have to have Formal bidding procedures on, we were able to look at the prequalification and encouragement of HUB firms.

This first year we obtained contractor lists from the North Carolina Institute of Minority Economic Development and the North Carolina Department of Administration's Office of Historically Underutilized Businesses. We determined a baseline for "invitation to bid" by going through two complete years of historic records - 1997-98 was 2.3% and 1998-99 was 3.2%. We set a target for 2000-01 HUB's invitation to bid at 8%. We incorporated qualified contractors from our lists into our current invited bidders list. In fiscal year 2000-2001, with the assistance of my new Assistant Director, Ted Devens, we had an actual HUB invitation ratio of 10.9%, resulting in an overall 22% utilization by dollars. This exceeded the goal by 9% and actual utilization by 120%.

When Senate Bill 914 passed in December 2001, we had the support we needed to affect a change for Formal projects, those now over \$300,000. In March 2002 NC State University demonstrated its commitment to utilizing minority contractors to meet the 10% goal established by the North Carolina General Assembly by being the first university in the UNC system to decide to hire a manager to develop and implement its HUB Construction program. I wrote a job description for the "new position" - which was later accepted by the other Universities - and had the major benefit of obtaining

Marvin Williams for the position at NC State University.

To better understand what was required to meet the participation goals, the University in the spring of 2002 held (4) meetings with minority design and construction firms, the first on April 11 - which Marvin fondly calls "A night to remember!!!" Construction and design firms openly and honestly stated their frustration with

their past efforts to do work for the NC State and the University system. Surveys completed during those meetings indicated that assistance to contractors was required in the following areas: training, communication, and NC State University's Good Faith Efforts. Marvin's responses to these surveys resulted in the following:

#### TRAINING CLASSES FOR HUB CONTRACTORS:

- Six Seminar Series Preparing Your Business to Participate on UNC Construction Projects(2003)
- Estimating Seminar 2-day session Conducted by NCSU Civil Engineering Department. (2003)
- Contractor Business Academy 16-week comprehensive business education program designed for HUB Contractors, covering all aspects of operating a successful construction business (2004). Feedback session with graduates (2006)
- Seminar "Keys to organizing your business" (2006)
- Seminar "How to prepare change order requests" (2006)

# **COMMUNICATIONS:**

- Numerous meetings with HUB organizations to present NC State University's HUB Construction program.
- NC State University developed a database of minority contractors and design firms for use by prime contractors seeking subcontractors and lead design firm seeking consultants
- Email list serve utilized by NCSU staff, as well as design and construction professionals, to communicate with like members of that group.

# NC STATE UNIVERSITY'S GOOD FAITH EFFORTS:

- Pre-Bid Meeting Attendance NC State University HUB Manager attends pre-bid meetings to make prime contractors aware of their responsibilities and requirements for soliciting minority contractors.
- Pre-submission design meetings NC State University HUB manager attends these meetings to emphasize the use of minority design consultants on University projects.
- CM at Risk Managed Projects Assist CM Managers in identifying and pre-qualifying minority contractors to bid as 1<sup>st</sup> tier subcontractors

- Plan Review Room Plans and specifications for projects out to bid are available for review in the NC State plan room
- HUB Program Manager thoroughly reviews all submitted Good Faith Effort documentation.
- Application for New Contractors Minority construction companies have been added to the informal projects bid list to bid projects less than \$300,000.
- Project Identification Identified informal projects for solicitation of bids from HUB contractors.
- Open Ended Service Agreements for Designers (OESAD) -Minority design firms have been added to this list to provide design services.

Last, but by far not least, we established our HUB Advisory Committee on May 14, 2002, consisting of design and construction professionals, representatives of HUB organizations, and the NC State HUB committee. The purpose of the committee has been to provide advice and counsel, and evaluate the progress of the NC State HUB Construction program. All members through the years have made a major commitment of time and effort to assist NC State in accomplishing, and exceeding, our

HUB goals.

In summary, as of July 2006, NC State University in the category of total contracts awarded to African American contractors vis-à-vis the total amount of construction dollars spent ranks 6<sup>th</sup> in the UNC system and first among historically white universities. North Carolina State University's African American participation rate was 5.1% (UNC System average—3.4%). Additionally, NC State University's Hispanic participation rate was 3.1% (UNC System average—2.5%). The overall minority participation rate at NC State University was 19.1%, which exceeds the 10% goal.

- You must submit a new prequalification application for each CM at Risk Project
- You are required to renew certification with the DOA/ HUB office yearly
