No. Item

- 1) MD presented findings regarding the Post Oak on Morrill Drive, Tree #3 on the Heritage Tree list. He stated that explorations with an air spade failed to find structural roots on one side of the tree. The impact of the GB noted that despite his observation that the tree has been leaning for decades and that the lean has not worsened noticeably over time, placing a walk underneath the tree's canopy would put people in the tree's target area if it or part of it should break or fall. The consensus was that the tree should be removed, and that the alignment of the crosswalk to be built across the driveway to the south should be repositioned to the optimal layout for pedestrian safety given it will no longer need to minimize impact to the tree.
- 2) MW suggested that the committee assess the health of all trees currently on the list. He suspects that there may be other trees on the list that would not have been viable candidates for a Heritage Tree. There was general agreement that this effort should occur over the course of the Spring semester, led by a working group of committee members. MW, GB, MD and DJ agreed to participate in the effort. DJ will lead the effort to create a plan and schedule for the working group.



- 3) LS noted that the decision to remove a Heritage Tree should not be taken lightly, and suggested that a process should exist to ensure that thorough consideration be given in this regard. There was general agreement that a written process was a good recommendation. GB noted that the committee's previous considerations regarding the removal of Heritage Trees seemed to be appropriate and thorough, and could provide the basis for the formalized procedure.
- 4) DJ suggested that the tree list be maintained at 25 trees or groves. Since the list will drop to 24 trees or groves with the removal of the Post Oak, he thought the committee should begin considering nominations to add a tree to the list.
- 5) The next meeting will likely be in February or March of 2017.
